As we met with her off and on over the course of the year, God was so patient with her, developing a trust relationship with each dissociated part before uncovering the next layer. In her words: "Meeting with you guys was the hardest thing I ever did in my life, but it was the best thing I ever did. Other therapies gave me the foundation to be able to face my pain, but inner healing prayer was the missing piece that brought it all together for full healing."

Sarah's story is just one of over 40 people our three-member team has prayed with this year alone. Each story is a testament to God's love and grace and power. Like most of our clients, Sarah cannot afford to donate much to our ministry, and so we rely heavily on "missionary support" to pay our bills.
